## SAFEGUARDING AT ANKERMOOR

At Ankermoor we strive to develop the whole child in order to 'bring the best' in all of them.

Whether you are in school as a member of Staff, a Governor, Volunteer or as a Visitor; we request you follow our policies and procedures which are designed to keep everybody safe.

Please ensure that you have signed in and that you wear your identification badge at all times whilst on the premises.

If you see any unaccompanied visitor or people acting suspiciously please report this to a member of staff **immediately**.

Confidentiality needs to be respected at all times. Breaches in confidentiality will be taken very seriously including communicating information through Social Networking Sites.

## **KEEPING CHILDREN SAFE**

If at any time during your visit to Ankermoor you have any concerns about a child or a child discloses any information that concerns you it is your responsibility to report this information to one of our Designated Safeguarding Leads immediately.

You may also be required to complete a Green Disclosure form which are located in the Staffroom on the Safeguarding board.

If you feel a pupil is at risk or the subject of abuse you must contact one of our Safeguarding Personnel.

You can also make a referral yourself by contacting First Response on:08001313126 or dialling 999

It is vital to report anything that causes you concern no matter how minor it may seem. Every bit of information is vital and forms part of the bigger picture.



## What you must do...

#### You should report any of the following signs:

- If the pupil is bruised or they have untreated injuries
- If the pupil is talking about violence at home
- If the pupil is acting in a way which is inappropriate for their age
- If the child is anxious, scared or withdrawn
- If the pupil is showing signs of neglect
- If a child discloses to you...
- Listen to the child
- Avoid using 'leading' or 'closed' questions
- Don't make assumptions-take what they are saying seriously
- Never promise to keep a secret
- Stay calm and reassure the child
- Record exactly what has been said using the child's language
- Pass on the information to the Designated Safeguarding Lead, using the Green Disclosure form, immediately
